



DONATING SECURITIES TO BRYAN'S DREAM FOUNDATION

To donate securities held as physical certificates.

1. **In the case of a securities certificate registered in the name of Bryan's Dream Foundation.** Please mail the certificate, using registered mail or a courier service that provides a return receipt, to Bryan's Dream Foundation, Attention: Secretary, at the address below. We suggest that you insure the mailing for 3% of the stock's market value, which is the approximate cost to replace a certificate in the event it is lost in transit. Concurrently, send an email to information@bryansdream.org notifying us of your plan to donate the securities.
2. **In the case of a securities certificate registered in your (the donor's) name.** In two separate mailings, using registered mail or a courier service that provides a return receipt, send to Bryan's Dream Foundation, attention: Secretary, at the address below:
 - a. The stock certificate, ***without any endorsement, assignment or other notation***, in the first envelope. We suggest you insure this mailing for 3% of the stock's market value.
 - b. The stock power form, ***with your signature and a Medallion Signature Certification only***, signed exactly as your name appears on the face of the certificate. A blank stock power form is attached. A Medallion Signature Guarantee is a special stamp provided by a bank, broker or credit union (guarantor institutions) that indicates that the individual signing the stock power form is legally authorized to conduct the requested transaction. Mail the endorsed stock power form in the second envelope.

Concurrently, send an email to information@bryansdream.org notifying us of your plan to donate the securities. Since your stock certificate will only be negotiable when the stock power is joined with the certificate, this method provides both safety and simplicity. When we receive the two separate envelopes, the Secretary will send an acknowledgement of your gift to Bryan's Dream Foundation.

To donate shares electronically:

Please first send an email to information@bryansdream.org notifying us of your plan to donate shares electronically and letting us know the brokerage firm name and DTC# from which the securities originate along with the securities' CUSSIP# and number of shares. We will then provide the information required for your broker to complete a DTC electronic transfer to **TD AMERITRADE** for the account of Bryan's Dream Foundation.
